RULES:

- Exhibitors must **DISPLAY** and Sell at least 90% knives and knife related material.
- (Scrimshanders & Engravers, Scrimshaw and engraving and related items, only please!)
- **Firearms and ammunition, switchblade knives, ballistic knives, butterfly knives, gravity knives and brass knuckle knives or other knife items prohibited by local law cannot be offered for sale.**
- The quality of the merchandise offered for sale must be commensurate with the quality of the show. Do not embarrass us both by having to be asked to leave.
- **TO ASSURE THE CONTINUING QUALITY OF KNIFE EXPO, DEALERS WHO KNOWINGLY OFFER COUNTERFEIT KNIVES OR ILLEGAL KNIVES FOR SALE WILL BE ASKED TO LEAVE AND WILL NOT BE ELIGIBLE TO PURCHASE TABLES IN THE FUTURE.**
- Tables should remain open during show hours listed above and must remain intact until the show closes on Sunday, 4:00 pm. Those leaving early without good cause may not be able to purchase tables for Knife Expo 2006. Upon receipt of your application, we will forward, at your request, flyers for your customers.

SECURITY:

- 24 hour security will be provided. Neither the Club nor the Pasadena Convention Center will be responsible for loss, damage or injury. No outside food or drinks, or pets will be allowed at Pasadena Convention Center.
- Walk in peddlers will be asked to leave and no one, except exhibitors, will be allowed behind the tables.

ADVERTISING: Advertising for this show will begin this fall. Ads will appear in Knife World, Blade Magazine, Knives Illustrated and other publications. These will run continuously until show time. Over 40,000 flyers will be distributed to all locations where the knife buying public may be found. We will also mail flyers to our mailing list of over 5,000 people. TAX INFORMATION:

THE STATE OF CALIFORNIA REQUIRES ALL EXHIBITORS TO HAVE A SELLER'S PERMIT OR EXEMPTION FORM COMPLETED – THE CLUB IS SUBJECT TO A \$1,000 FINE FOR VIOLATIONS.

- If you are selling and have a permanent California Seller's Permit – Submit a copy to Knife Expo
- If you are not selling you must have an exemption document approved by the State of California – Submit a copy to Knife Expo
- If you do not have a seller's permit – You must obtain a valid permit before the show and submit a copy to Knife Expo
- If you are not regularly engaged in business – you must obtain a valid temporary seller's permit and submit a copy to Knife Expo
- If you are from Out of State and Selling – you must obtain a valid temporary seller's permit and submit a copy to Knife Expo.

A PHOTOCOPY OF YOUR VALID CALIFORNIA SELLERS PERMIT OR VALID EXEMPTION FORM MUST BE PROVIDED TO KNIFE EXPO BEFORE TABLES WILL BE ASSIGNED.

IF YOU DO NOT HAVE A VALID CALIFORNIA SELLER'S PERMIT OR EXEMPTION YOU WILL NOT BE ALLOWED TO SET UP AT THIS SHOW
